

SERVICE CONTRACT

Terms & Conditions:

"Just Beclaws Petsitting Service" will be referred to herein as "Just Beclaws". The parties herein agree as follows:

- 1. The initial term of this contract shall be from (date/time Sitter's first visit) ______ through (date/time Sitter's final visit) ______. In the event of early return home, Client must notify Just Beclaws promptly to avoid being charged for unnecessary visit(s). Sitter will not extend visits beyond date/time of final visit listed above unless contacted by Client with an extension request.
- 2. Fees for the services required as listed on this contract and the dates listed above shall be \$_____ per 20 35 minutes (sometimes longer if necessary for the health and safety of the pet/s), a \$6 holiday weekend surcharge (one charge for the weekend) and/or a \$12.00 holiday surcharge (for the actual day of the holiday) when applicable. During certain holiday periods, some visits may be 15 minutes long due to the extremely busy nature of the holiday schedule. Should the Sitter need to obtain food, vitamins, litter, or any other necessities required for pet care that the Client fails to adequately supply Just Beclaws shall be reimbursed by Client for costs plus \$15.00 service fee
- 3. In the event that Just Beclaws is required to employ a locksmith to gain entry into Client's premises due to a malfunction of the lock or a failure of the Client to leave a key, it shall be the responsibility of the Client to reimburse Just Beclaws for all costs incurred. The Client expressly gives Just Beclaws the authority to employ a locksmith on Client's behalf in the event of the aforementioned occurrences.
- 4. Just Beclaws requires payment in full at or by the first visit. Refunds and/or credits will be provided due to early return of clients, client cancelled sits, over-charging, etc. Any balance on account because of client cancellations after payment will remain in account as a credit to be used for future service. A finance charge of \$3.50 will be added to unpaid balances after fifteen (15) days and will reoccur every fifteen (15) days until the balance is paid in full. A handling fee of \$35.00 will be charged on all returned checks. In the event it is necessary to initiate collection proceedings on the account, Client will be responsible for all attorney's fees and costs, court costs, and costs of collection. It is agreed by the

parties that Orange County will be the venue for any suit brought hereunder.

- 5. Just Beclaws is authorized to perform care and services as outlined on this contract. Just Beclaws is also authorized by signature below to seek emergency veterinary care with release from all liabilities related to transportation, treatment, and expense. Should specified veterinarian be unavailable, Just Beclaws is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. Client agrees to reimburse Just Beclaws for expenses incurred, including a transportation fee, plus any additional fees for attending to this need.
- 6. Just Beclaws reserves the right to terminate this contract at any time before or during its term if Sitter and/or Just Beclaws, in its sole discretion, determines that Client's pet poses a danger to the health or safety of the Sitter. If such concerns prohibit Just Beclaws from caring for pet/s, Client authorizes pet to be placed in a kennel, with all charges thereafter to be charged to Client.
- 7. In the event of inclement weather or natural disaster, Just Beclaws is entrusted to use their best judgment in caring for pet(s) and home. Just Beclaws will be held harmless for consequences related to such decisions.
- 8. All pets are to be currently vaccinated, collared, tagged and/or microchipped. If Sitter should be bitten or otherwise exposed to any disease or ailment received from Clients pet/s, whether or not it has been properly and currently vaccinated, it will be the Client's responsibility to pay all costs, such as medical treatment and damages incurred by the victim. We recommend proper identification of your pet while in our care, because if your pets become lost, you have a much greater chance of having your pet returned to you if it has proper identification.
- 9. Client authorizes this signed contract to be valid approval for future services of any purpose provided by this contract permitting Just Beclaws to enter premises without additional signed contracts or written authorization.
- 10. Just Beclaws will provide the utmost care for both your pet(s) and your home. However, due to the extreme unpredictability of animals, Just Beclaws cannot accept responsibility for any mishaps of any extraordinary or unusual nature (i.e. biting, furniture damage, accidental death, etc.) or any complications in administering medications to the animal or any ill effects thereof Just Beclaws cannot be liable for injury, disappearance, death, or fines incurred by pet(s) with access to the outdoors by way of doggie door or similar, or if clients instruct us to walk their pet/s, let out to potty in an unfenced backyard, or similar without a leash.
- 11. Pricing is subject to change due to inflation, increased fuel charges, mileage over 12 miles one way, etc., without notice, and at the discretion of Just Beclaws.
